Applicant's Request

Within the scope of Article 11 of the Law No. 6698 on the Protection of Personal Data (" KVKK "), everyone has the right to apply to Oytaş Yıldız Construction as the data controller:

- c) Learning the purpose of processing personal data and whether it is used in accordance with its purpose,

- f) In accordance with Article 7 of the KVKK, to request the deletion or destruction of personal data within the framework of the conditions envisaged in the case of the reasons for the processing, even though it has been processed in accordance with the provisions of this Law and other relevant laws,
- g) To request notification of transactions made in accordance with subparagraphs (d) and (e) to third parties to whom personal data are transferred,
- h) To object to the emergence of a result against the person by analyzing the processed data exclusively through automated systems,
- i) Requesting the removal of the damage if any damage occurs due to the illegal processing of the data. ”
